

## NOTICE ON PROTECTION OF PERSONAL DATA

In compliance with Legislative Decree. n° 196 dated 30 June 2003, as amended by the Italian Legislative Decree N° 101 dated 10 August 2018, (“**Privacy Code**”) and of the European Regulation 2016/679 (“**Privacy Regulation**”), **Tecnosystemi S.p.A. Società Benefit** (Tax Code and VAT N° 02535780247) with registered office in 31029 Vittorio Veneto (TV), Via dell’Industria 2/4, e-mail [info@tecnosystemi.com](mailto:info@tecnosystemi.com) (hereinafter, the “**Data Controller**”) would like to inform you that, should you grant express consent (pursuant to article 6, section 1, letter a) of the Privacy Regulation), your personal data will be processed to keep you up to date with all promotion initiatives of the Processor (the “**Newsletter**”).

The data submitted by you will be mainly processed using paper and/or electronic media under the supervision of the Data controller, by the persons specifically designated, approved and trained to process the data (pursuant to article 2-*quaterdecies* of the Privacy Code and pursuant to article 29 of the Privacy Regulation). We inform you that suitable security measures are complied with also pursuant to articles. 5 and 32 of the Privacy Regulation to prevent data loss, unlawful or incorrect use and unauthorised access.

The data may be disclosed, within the EU, fully complying with the provisions laid down in the Privacy Code and in the Privacy Code, to the following parties: financial administration and/or other public authorities, where this is required by the law or upon their request; to facilities, to parties and to external companies used by the Processor to perform the related activities, which are instrumental to or stemming from performing the Newsletter service; external consultants, if not designated as Data Processors in writing.

The updated list of the designated Data Processors may be provided upon request by the parties involved to the e-mail address of the Data Controller.

The data required to send the Newsletter will be processed until the involved party exercises the right of unsubscribing from the Newsletter by revoking the granted consent.

Articles 15 et seq. of the Privacy Regulation give the data holder the right to obtain, in the manner and within the limits established by art. 2-*undecies* of the Privacy Code and art. 12 of the Privacy Regulation:

- confirmation of the existence or otherwise of personal data concerning them, even if not yet registered, and their communication in an intelligible form;
- the indication of the origin of the personal data, the purposes and methods of processing, the logic applied in case of processing carried out with the aid of electronic instruments, the identification details of the controller;
- the update, correction, supplementation, deletion, transformation into anonymous form or blocking of data processed in breach of the law - including those whose storage is not necessary

in relation to the purposes for which the data are collected or subsequently processed -, the certification that such operations have been brought to the attention, also with regard to their content, of those to whom the data have been communicated or disseminated, except in the case in which this compliance proves impossible or involves a manifestly disproportionate use of means with respect to the protected right.

The data subject also is entitled:

- to revoke at any time the consent (where given) to the processing of personal data (without prejudice to the lawfulness of the processing based on the consent given before the revocation);
- to oppose, in whole or in part, for legitimate reasons, the processing of personal data concerning them, even if pertinent to the purpose of the collection;
- to oppose, in whole or in part, the processing of personal data concerning them for the purposes of sending advertising material or direct sales or for carrying out market research or sales communication;

- to the portability of personal data within the limits envisaged in art. 20 of the Privacy Regulation.
